Sir/Madam,

I have been directed to invite your kind attention to the Notification No. CBSE/AFF/19/2004/23322-30567 dated 12.10.2004 through which the amendments made by the CBSE in the Affiliation Bye-Laws of the Board w.e.f. 18.6.2004 were notified. It is further informed that an Amendment in Rule 3.2 (iv) was with reference to the grant of :

"Regular affiliation to schools run by the Govt./Govt. Aided/Kendriya Vidyalaya Sangathan (KVS)/Navodaya Vidyalaya Samiti (NVS)/Central Tibetan Schools Organisation (CTSO)"

In view of the above amendment in the Rules and the decision taken by the Board, I have been directed to inform you that:

- The above mentioned new schools will now be given 'Regular Affiliation' only, and the affiliation fee. 1. will remain the same i.e. Rs.7000/-
- The Provisional Affiliation of the existing schools, who at present are only 'provisionally affiliated' with the Board, has been converted into 'Regular Affiliation' and these schools need not apply for 2 further extension. However, they will continue to pay the Annual Fee, @Rs.1500/- instead of Rs.1000/-
- The Annual Fee will regularly be remitted by all the schools along with the fee remitted for the Annual 3. Examinations of the Board.

You are requested kindly to do the needful accordingly and specifically mention while remitting the Examination fee along with the list of candidates about the Annual Fee being remitted so that it may properly be accounted for. In case any school is required to remit outstanding Annual Fee the same may also be added in the fee remitted for examination and it may specifically be mentioned in the details so that fee remitted by the school is properly accounted for and there is not any Audit objection.
